



Guidelines for submission of paper in International Conference on Research in Business Studies

Guidelines for Manuscript Submission Process

1. Papers should be original work, previously unpublished, and not currently being reviewed for publication with another journal.
2. Paper must be written in English language.
3. Submissions should be in Times New Roman font, font size 12 with 1.5 line spacing, and 1.0-inch margins on all sides of A4 (including references, appendices, tables and figures).
4. Submissions must be compatible with Microsoft Word 2007 and higher versions.
5. The principle divisions of the manuscript should appear in the following order:
 - 5.1. Page 1
 - 5.1.1. Title (limit 20 words)
 - 5.1.2. Author names and details (maximum 6 lines)
 - 5.1.3. Abstract (limit 250 words). It would not be counted as paper text.
 - 5.1.4. Keywords (minimum 5 keywords)
 - 5.2. Page 2 onwards
 - 5.2.1. Body of the article
 - 5.2.2. References
 - 5.2.3. Appendices.
6. Body of the article consists of following:
 - 6.1 Introduction
 - 6.2 Objective of the study
 - 6.3 Scope of the study
 - 6.4 Literature Review
 - 6.5 Research Methodology/ Database
 - 6.6 Limitations
 - 6.7 Findings & Suggestions
 - 6.8 Conclusions
7. The above mentioned structure may vary depending on the nature of the research look.
8. There is no limit to the number of co-authors in a paper.
9. **References** should be in alphabetical order by author, following the *American Psychological Society* style (APA) style (<http://www.apastyle.org/>). The author is responsible for providing complete and accurate citations.
10. All supporting files including figures and illustrations, tables, and images must be submitted within the text.
11. The title of each appendix should be typed in sentence case, centered, and bold-faced.
12. Every page in the manuscript should contain a short running head and the page number. This information should be right justified.
13. As reviewer often prefer to write notes on the manuscripts, authors should use one inch (2.54cm) margins.

Process of Publication:

1. All papers will be peer reviewed by the Scientific Committee which reserves all the rights to accept or reject the paper for inclusion in the conference.
2. Papers must be submitted electronically through the online submission tracking system at <http://icrb.international/submit.php>.

Publication Opportunity:

All the accepted papers stand a chance of publishing with International Journal of Research in Business Studies (IJRBS), after incorporating suggested modifications, if required.
